# CIA THINK-TANK PLANS ECONOMY OF "ANTI-IMPERIALIST" AL ERIA

Oct. 30 (IPS) -- In a major expose of Rockefeller's control over the political economy of so-called militant Arab nationalism, IPS has discovered an intimate relationship between Herman Kahn's Rockefeller-funded think-tank, the Hudson Institute, and the phony radical government of Algeria.

According to the 1973 Hudson Institute "Report to the Members," the notorious CIA-connected Hudson Institute has been involved deeply in the entire range of Algeria's public sector heavy industry under the Algerian Ministry of Industry and Energy. One of the explicitly stated objectives of the Algerian contract with Hudson is "to provide an ongoing contact and dialogue between Algeria's industrial leaders and various large, multinational firms and banks." Virtually the entire Algerian economy has been planned and reshaped under Hudson direction.

A spokesman for Hudson Institute told IPS that the current "socialist" Four Year Plan that governs Algeria's oil-rich economy was authored by Hudson planners. The spokesman added that "of course, Algeria did not give us public credit for our work."

A source close to the Algerian government told IPS that the loud-mouthed "anti-Americanism" of Algerian President Boumedienne was merely a public relations maneuver. "In a recent meeting with Kissinger, Boumedienne told the Secretary of State that he was sorry for having to make that kind of noise," he said, referring to Algeria's well-known anti-imperialist blustering.

IPS is trying to obtain a statement from the Soviets on this matter. While the USSR and the French Communist Party often pay tribute to Algeria as a bastion of anti-imperialism, they undoubtedly would be interested in knowing that the same Hudson Institute now working feverishly to conceive a strategy for nuclear warfare against the Soviet Union, on contract with the CIA and the Defense Department, concurrently is directing the Algerian economy.

# MIDEAST WAR IN MAKING: ROCKEFELLER FORCES HEIGHTEN NATIONALIST FEVERS

Oct. 30 (IPS)--The plans of Rockefeller's Trilateral Commission to provoke a fifth Arab-Israeli war received a major boost by the manipulated decision at the Rabat Arab summit meeting to back the CIA-controlled Palestine Liberation Organization (PLO) over the protesting squawks from butcher King Hussein of Jordan. Given the oftenstated Israeli refusal even to consider negotiating with the PLO, which the Zionists label a "terrorist gang," the Oct. 28 decision in Rabat sets the stage for a full-scale Arab-Israeli war--including

the possible introduction of nuclear weapons by the desperate and isolated Israelis.

Although the Israeli government so far has refused to issue a public statement on the PLO decision at Rabat, on Oct. 26 the Israeli Defense Force began a series of major war games on the explosive Golan Heights and throughout the West Bank, scheduled to last several days. Israel is also on a national alert for terrorists, with numbers of Civil Guards and paramilitary forces mobilized. IPS could find no Israeli government spokesman willing to comment on the tense situation.

Israeli Chief of Staff General Gur said over Israeli radio that Israel was preparing for war in case peace efforts fail. He claimed that Israel would launch a blitzkrieg against the Arabs to "end the war quickly." However, the Labor Committee Intelligence Staff has determined that a conventional war on Israel's part would be a disaster, adding another reason for the Israelis to exercise their "nuclear option."

By virtue of the Rabat summit of Arab heads of state, Egypt, Syria, Jordan, and the PLO have agreed to form a unified command prepared for war. Thus the stage has been set for the CIA to provoke another Middle East war in the tinderbox conditions that now prevail, by orchestrating the feverish nationalisms on both sides.

### BUTZ BACKS INCREASED PRODUCTION

Oct. 30 (IPS)--Countering the Rockefeller mass starvation plan which will be pushed at the upcoming United Nations World Food Conference in Rome is the Chief U.S. Delegate to that conference, Agriculture Secretary Earl Butz. In a televised debate last weekend with key Rockefeller mouthpiece for genocide Lester Brown, Butz asserted the only human solution to the contrived food shortages: increased production.

In sharp contrast to the four Rockefeller agents on "Meet the Press" Butz said: "The real need is to produce more. Our food policy is one of full production. Governments don't produce food. Only farmers produce food. The World Food Conference doesn't produce food: Only farmers produce food." For the first time, Butz directly attacked several Senators by name for their positions which prevent efforts to cut food prices. Senators Humphrey (D.-Minn.) and Jackson (D.-Wash.) were mentioned.

Dr. John Hannah, Deputy Secretary General of the World Food Conderence; Prof. Jean Mayer of Harvard University; Lester Brown; and Rockefeller Foundation Vice-President Dr. Sterling Wortman disagreed. They called on the world working class to cut down on consumption, particularly consumption of animal products.

Brown's solution to the immediate food problem is "Short run, stepped up food aid from the United States. Long term, putting the brakes on population growth." In other words, immediately lower the standards of living for the entire world working class while eliminating "excess" population by starvation.

Butz pointed out that "We do wrong when we talk about cutting back in the consumption of meat, or eating one less hamburger per week." For his assertion that full production is the only remedy, Butz has come under continuing attack by the Rockefeller forces in the Congress and in the press.

# THE SHAH PLANS TO BRING FRANCE'S NUCLEAR CAPACITY UNDER ROCKEFELLER CONTROL

Oct. 30 (IPS)--Shah Reza Pahlevi of oil-rich Iran has announced his intention to buy up 20 per cent of the shares of France's major nuclear and special steel plant producer, Creusot-Loire. In exchange, Iran will create a national company in charge of steel-based industrial development, of which Creusot-Loire reportedly will own 20 per cent.

This projected deal, which follows by a few weeks a similar agreement concluded in West Germany between the Shah and Kruppwerke, will result in "foreign interests" completely taking over the French nuclear industry. Nuclear research and the uranium enrichment process will still be dominated by domestic interests and the government. But all production of nuclear plants will be safely in the hands of Rockefeller-controlled firms or Rockefeller allies, such as Compagnic Generale de l'Electricite (closely associated with Rocky's very own General Electric) and Creusot-Loire. At the latter, the alliance of Baron Edouard-Jean Empain, a Belgian capitalist linked with Westinghouse, and the Shah will dominate the company.

At this point, it seems the Shah's participation in Creusot-Loire had been in preparation for some time. Since the end of 1973, Empain has been striving to get rid of its main partner on the Creusot-Loire board, old French steel producer Marine-Firminy. A few weeks before the announcement of the Shah's intention to acquire the Creusot-Loire shares, Marine-Firminy informed the press that it was "thinking of divesting itself of its assets in the nuclear venture." A few steel magnates led by Jacques Ferry, a major organizer of Rockefeller's deindustrialization and relocation schemes for Europe, then expressed their desire to take over Marine-Firminy's conventional steel-works.

One of the related advantages of the Shah's operation is that he will partly control the steel industry of Soviet-allied Iraq, since Creusot-Loire has just concluded an agreement with the Iraqi government. The French firm agreed to build two steel plants and supply various capital goods to Baghdad.

There is no way of telling whether the Shah's appetite will be satisfied with this initial push into French corporate boards. Should he choose to "diversify" his portfolio and penetrate other companies, he may very well be attracted by Eurofuel, a recently-created venture in chrise of prospecting and mining uranium deposits for France. This firm currently is controlled by Westinghouse, Creusot-Loire, and Pechiney, the well-known non-ferrous metals producer. Such a move would guarantee the Shah with safe and regular supplies of uranium ore, a necessary precondition for the development of a powerful nuclear force.

# LE MONDE BOOSTS TRILATERAL COMMISSION'S PSYWAR AGAINST SOVIETS

Oct. 30 (IPS)--To carry out the policies determined by the fascist Trilateral Commission at its secret meeting in Bellagio, Italy two weeks ago, the cabal has stepped up its press campaign to isolate and crush the Soviet Union.

Writing in the Oct. 28 issue of the French daily <u>Le Monde</u>, Trilateral Commission member Michel Tatu explained the tactics used against the Soviet Union by analyzing military questions as psychological problems, centering on the effects of the threat of nuclear war.

Tatu notes that the recent U.S. launching of an intercontinenta missile from an aircraft flying above the Pacific "casts a doubt on Kissinger's vigorously asserted intentions to limit the armament race." CIA Sovietologist Tatu concludes: "On their side, the Soviets are reportedly interested too in mobile devices, but launched from the ground, for instance, from ramps circulating on the country's railroads. At least, this is what the U.S. Intelligence Services have leaked out, maybe in order to prepare the opinion to the current air launching tests. Has Mr. Kissinger tried to give himself a bargaining chip whose abandonment he would negotiate against Soviet concessions? The past experience has shown that these bargaining chips turn rather quickly into actual programs, consequently into new stages in the armament race." Thus Tatu already has laid out one side of the tactic used against the Soviet Union: Military questions are analyzed as psychological problems.

While the threat of a thermonuclear exchange escalates in the press, the Soviets in addition are falling for the "soft" side of the cabal's tactic: The mythical "winds of detente" that emanate from Rockefeller to obfuscate the real war he is preparing.

Last week, Soviet TV carried an interview of French President Giscard d'Estaing in which he expressed his deep attachment to "good Franco-Soviet relations." This obvious sham so far has been noisily greeted by the Soviets as another proof of the Rockefeller-controlle Western world's good intentions.

#### THE SHADOW

Oct. 30 (IPS)--The United Electrical Workers local at the Electro-Voice, Inc. plant in Newport, Tennessee has just won a new paid holiday: February 2, Groundhog Day. Rumor has it that when the worker staggers out of his plant on that day, if does not see his shadow, he gets laid off. If it is sunny and he sees his shadow, he goes back inside the plant to work and does not emerge again until Spring.

### WEST GERMANS PURSUE DETENTE PSYWAR IN SOVIET UNION

Oct. 30 (IPS)--Three major delegations from West Germany visited the Soviet Union last week for economic and psychological warfare purposes. Accelerating the anti-Soviet offensive which began with Nelson Rockefeller's San Francisco speech to UPI editors Oct. 3, they exacerbated the Soviets' grave confusion about the detente policy on which to date they have foolishly staked their existence.

### Three Delegations

Otto Wolff von Amerongen, member of Rockefeller's Trilateral Commission and the executive board of Exxon, led a delegation to Tbilisi, Georgia for a USSR Academy of Sciences symposium on economic cooperation between the Soviet Union and West Germany. In the past month, Amerongen has been a leading field organizer for the Rockefeller interests vis a vis Eastern Europe, travelling to Poland and the USSR. In both places, he held out the promise of West German credits only to back down when it came to concrete agreements on joint projects.

On this mission, Amerongen brought along a gaggle of German industrialists, scientists, and a trade unionist from his own German Society for the Study of Eastern Europe. Among them was Richard Loewenthal, long-time counterinsurgent from the Second (Social Democratic) International and associate of the American anti-communist quack, Sidney Hook.

The Soviet newspaper <u>Izvestia</u> meekly billed the visit of this enemy squadron as a "scientific conference."

Outside Moscow, a group of German bankers met with Soviet trade organizations to discuss the financing of a Soviet purchase of trucks An insignificant arrangement compared with the major projects that are being held up, this kind of deal serves to fuel the illusion of progress in detente through East-West trade.

West German Chancellor Helmut Schmidt got great fanfare for his trip to Moscow, but little more than that. Schmidt kept up the appearance of detente with sincere-sounding praise for the four-year-old Moscow Treaty, the cornerstone of former Chancellor Willy Brandt's

Ostpolitik, actually blocking agreements with the Cold War issue of West Berlin. Concerning the fission power plant planned for Kaliningrad, for example, Schmidt repeated Amerongen's demand from two weeks ago that its power grid must include West Berlin.

All the Soviets bought through Schmidt was 1.5 billion marks worth of steel pipeline on credit. It is possible, although unconfirmed, that this pipe will carry Iranian oil through the Soviet Union to West Germany.

According to the West German newspaper Frankfurter Rundschau, Schmidt waited until after dinner on the last day of talks to toss a psywar barb at Soviet party chief Leonid Brezhnev. Brezhnev commented that Franz-Joseph Strauss, who has just seriously defeated Chancellor Schmidt's Social Democratic Party in regional elections (see IPS below), is a Cold War revanchist. Schmidt, the newly self-proclaimed champion of Ostpolitik then defended the fascist Strauss:

The chill this sent through Brezhnev points to the truth: There is no possibility of detente as the Soviets conceive it. Continuing to block out this reality, they are sitting ducks for Rockefeller.

# U.S. LABOR PARTY MOVES TO COUNTER MURDER THREATS BY UNITED AUTO WORKERS OFFICIALS

LORAIN, Ohio, Oct. 29 (IPS) -- The United States Labor Party is taking legal and political action today against leading officials of the United Auto Workers after the second armed murder threat by UAW officials against Labor Party organizers within a week occurred at the Ford Lorain plant yesterday.

Labor Party Michigan State Senate candidate James Eades, threat ened at gunpoint at the plant gate yesterday, immediately registers a complaint with Loraine police and filed charges this morning. Labor Party lawyers are also in the process of filing charges of conspiracy to commit assault with attempt to commit murder. Named in the suit in addition to yesterday's assailant will be UAW President and Trilateral Commission member Leonard Woodcock; UAW Director of Region 2A, William Cass Stevens; and Ford International Representative for Region 2A, Sam Carr.

Labor Party organizers and supporters already are prepared for national mobilization if a return rally today at Ford Brookpark in Cleveland, where earlier murder threats and attacks have occurred, is attacked again. Labor Party forces have been alerted to take action around the new Loraine attack.

Eades was taking part in an electoral campaign <u>New Solidarity</u> distribution at the Ford Loraine plant in Loraine, Ohio when the homicide threat occurred.

A Ford Fairlane automobile pulled up to the curb near the Labor Party distributors. The driver, who was wearing a UAW jacket bearing the name-patch "Osborne--UAW Committeeman," beckoned Eades over to the car as if to ask a question. As Eades leaned close over the open car door, "Osborne" suddenly pulled a .38 caliber revolver from under the car seat. Shoving it into Eades side "Osborne" said, "Nextime you come here, I'll blow you away!"

In addition, "Osborne" will be charged with concealing a deadly weapon and assault with intent to murder. Tomorrow, the U.S. Labor Party will deliver a letter to Acting President of Ford Local #425, Mike Cumberlage, demanding that "Osborne" immediately be dismissed from his position as Committeeman and delivered over to the appropriate authorities for psychiatric examination and treatment.

Evidence of a Woodcock-directed conspiracy against the Labor Party is overwhelming. Prior to today's threat of murder in Loraine Labor Party organizers elsewhere in Ohio this month have been subjected to thug attacks at the Perrysburg Chrysler plant near Toledo, and to attempted thuggery, obscene phone calls, and telephoned bomb threats from the UAW local President Wayne Medders of Cleveland Ford Brookpark. Other simultaneous incidents of harassment directed by UAW officials occurred in Detroit; Wilmington, Delaware; Rock Island, Illinois; Indianapolis; and Syracuse.

The intent behind the conspiracy is to cripple and contain U.S. Labor Party organizing which successfully has focused the growing politicization of auto and other workers against the fascist National Employment Priorities Act, authored by Trilateral Commissioner Woodcock's staff and sponsored by Trilateral Commissioner Senator Walter Mondale. The Labor Party campaigns especially have exposed massive in-plant drug, alcohol, and "troubled worker" brainwashing programs aimed at militants, which Woodcock has pioneered for Rockefeller, and Woodcock's role in planning the Nov. 12 "coal strike" to engineer industrial collapse.

# ITALIAN CP CHIEF AMENDOLA BACKS ROCKEFELLER'S LINE FOR EUROPE

Oct. 29 (IPS)--In a public speech Oct. 26, Giorgio Amendola, the Rockefeller agent in the Italian Communist Party (PCI), called for making Europe into a "third force."

This is precisely the strategy outlined by the Rockefeller Trilateral Commission's secret meeting in Bellagio, Italy two weeks ago.

To make sure he would not be misunderstood, Amendola identified his demands as identical with a proposal by Altiero Spinelli. Spinelli, the Italian Common Market Commission representative, is a CIA agent and fellow traveler in Trilateral circles. In his speech, Amendola also mouthed the fascist Zero-Growth line put forward by John D. Rockefeller III and he demanded an explicitly corporativist solution to the present economic crisis.

Amendola's colleague in the Italian Communist Party's Central Committee, Gian Carlo Pajetta, called for a merger of the PCI with the infamous Second International in an interview in the PCI's weekly Rinascita. Identified long ago by the Soviet Union as a bevy of agents, the Second International is now dominated by agents like United Auto Workers President Leonard Woodcock and Austrian Chancellor Bruno Kreisky. Fresh from the Warsaw conference of European Communist Parties where he helped lead the implementation of a Chilestyle "National Road to Socialism" turn, Pajetta elaborated on Amendola's plans to sell out Italy's working class. Pajetta in the Rinascita interview dug up the Yalta Memorandum, which infamous PCI leader Palmiro Togliatti issued from his deathbed. This memorandum insists on the "National Roads" theses which successfully aided the spineless Togliatti in subverting the Italian revolution after World War II.

The situation, engineered by traitors in the PCI leadership, was summarized by the financial daily <u>Il Globo</u>. Controlled by key Rockefeller operative Ugo La Malfa, <u>Il Globo</u> proclaimed that detente is dead because world communism is in shatters.

### GISCARD'S GOVERNMENT TO DISMANTLE FRENCH INDUSTRY

Oct. 29 (IPS)--In an unusually frank interview with the Paris daily Le Figaro, French Minister of Industry Michel D'Ornano conceded Oct. 26 that he is a key man in charge of implementing Rockefeller's deindustrialization plan for France.

The crux of his program rests on one simple fact: That "the ne increase in oil prices will impose a scarcity economy on France." With this principle of his policy made clear, D'Ornano outlined the remedies to the crisis:

- (1) Eliminate "waste" and reduce the consumption of industrial fuel. This the Minister proposes to accomplish primarily by forcing industrial firms to "retool." Given the drastic credit restrictions imposed by the French government on the entire industry, necessary funds will be made available for this purpose upon recommendation by the Minister, "case by case." In other words, D'Ornano will selectively blackmail French industrialists into submitting to the Rockefeller relocation plan. If they do not, he will provoke their bankruptcy.
- (2) Imports of natural gas and coal from the USSR, the North Sea, and Iran will be increased, while the French coal mining industry is shut down.
- (3) The nationalized Electricite de France and Gaz de France concerns, already heavily in debt, will have to finance their operations on the French or foreign financial markets, whether there is credit available or not. Anyhow, French consumers will not be babied any longer, D'Ornano said, "as we must progressively tend toward truthful prices (sic) for electricity and gas in 1975 and the following years."
- (4) Deals between oil-producing countries and France are a good thing, according to D'Ornano. "We must help them build up their heavy industry, their auto industry in particular," he stated. As a result, D'Ornano favors "diversification" (dismantling) policies for Renault and industrial "cooperation" (i.e., export of both capital goods and labor to the Third World).

The actual nature of D'Ornano's fascist functions is no longer a secret. As Le Figaro notes at the end of the interview, D'Ornano' responsibilities seem to grow as he is less and less "Minister of Industrial and Scientific Development." "Development" is simply out of the question, Le Figaro states. On the other hand, D'Ornano may claim soon to be called "Minister of Reconversion." "We should add: of permanent reconversion," concludes Le Figaro.

#### TERROR ERUPTS AT LINCOLN DETOX

NEW YORK CITY, Oct. 29 (IPS) -- The U.S. Labor Party is consulting its legal advisors to determine appropriate compensation for criminal slander committed -- one week before the New York elections in which the Labor Party is running -- by WNEW TV Channel 5 on its 10 o'clock evening news tonight in New York City, tying the U.S. Labor Party to the death of Lincoln Hospital's Dr. Richard Taft.

In a deliberate attempt to silence Labor Party exposure of Lincoln Hospital's Detoxification Unit as a brainwashing center, WNEW newscaster Bob O'Brien introduced a Lincoln Drug Center Security Officer identified only as "Georgie" who proclaimed "suspicion" of the Labor Party's connection to Taft's death. Taft's body was discovered in a Dancoln Hospital storeroom today. In addition to legal measures the Labor Party has demanded full retraction and an equal-time reply from WNEW.

Readers of New Solidarity and IPS in the May-June 1974 period know that the U.S. Labor Party at that time demanded:

\*Grand jury investigation into the assault--led by Dr. Richard Taft--against Labor Party organizers Tom Archer and Ned Rosinsky at a Labor Party press conference outside Lincoln Hospital's Detoxification Unit May 15. Dr. Taft personally fingered Rosinsky, a former intern at Lincoln Hospital, for assassination. Archer was shot during the attack.

\*That Bronx District Attorney Mario Merola conduct a full investigation into the Lincoln Detoxification Facility, its administration, and its doctors, including Dr. Taft.

\*The shut-down of the Lincoln Detox brainwashing institution, national center of the CIA-terrorist Black Liberation Army operation.

\*Thorough investigation of the Black Liberation Army.

The Labor Party issued these demands as a warning: Lincoln Detox is a factory that produces killers. The evidence is on Mario Merola's desk--where it has been for six months. Any investigation that does not proceed from this evidence is ipso facto incompetent. Any newspaper which does not report this evidence is guilty of withholding vital information from the public. Refusal to base the investigation into Taft's death on the evidence provided to Merola six menths ago by the Labor Party is a deliberate fraud, cloaking the real circumstances surrounding his death.

WIESBADEN, BRD, Oct. 29 (IPS)--Election fraud against the European Labor Committee (ELC) candidate in the West German Hesse state elections was confirmed today through an "official" ELC vote tally of only 23 votes. In a manner similar to the election fraud against the U.S. Labor Party in the last Newark, New Jersey elections, Rockefeller agents in either the Social Democratic Party or the neo-fascist Christian Democratic and Social Unions made certain that this election would not be a working class mandate. All the Maoist candidates, though, somehow managed to pull 1.6 per cent of the total vote for their mangy, anti-working class countergangs--even though the German Communist Party, which has an actual working class base, tallied only 2.1 per cent of the vote.

These election frauds only add credibility to the working class potential that the ELC is creating in European politics. Agents do not waste time stuffing ballot boxes unless they feel that they have to stop the ferment around the Labor Committees by all possible mear

#### TRUDEAU PUSHES TRILATERAL LINE IN EUROPE

Oct. 29 (IPS)--In a press conference in Brussels Oct. 25, Canadian Premier Elliot Trudeau bared the purpose of his Rockefeller-rigged mission in Europe. After a week of European press hoopla about his recent "anti-U.S." intentions, and immediately following his visit to NATO headquarters, Trudeau complained that his trade propositions have not been taken seriously enough by the Common Market.

Addressing the Europeans on the eve of his return to Canada, Trudeau exclaimed: "You might think you are going to get all our raw materials; well, you're wrong!" Trudeau also announced that he had informed the EEC Commission that Canada now was adopting a drastic new policy in terms of energy, natural resources, and foreign investments—essentially, Rockefeller's labor intensive energy "development" plan. He then stated that "the problem with the Common Market is that it has not yet found its 'identity'."

Trudeau's warning was intended to push the strategy laid out two weeks ago by the Rockefeller cabal at the secret Trilateral Commission meeting in Bellagio, Italy. The "identity" meant was that of the "disengaged Europe." This concept of a "neutral, united Europe" is designed to lure the Soviet Union into thinking that Europe will act "independently" of the U.S.

Significantly, the press conference was not covered in the mair Canadian press, although Trudeau's trip to Europe was preceded by a heavy "anti-U.S." nationalist campaign in Canada in which the tightening of the Canadian-EEC cooperation was presented as the "last alternative" for Canada.

### TANAKA WATERGATING ESCALATES

Oct. 29 (IPS) -- The Watergating of Japanese Prime Minister Takeui Tanaka has been stepped up. Yesterday, Tanaka was forced to issue a Nixon-style statement denying that he would resign, despite newspaper rumor-mongering and demands from both the opposition and members of his own party that he do so.

In spite of his denial, the speculation continues. The <u>New Yor</u> <u>Times</u> and the London <u>Financial Times</u> have suggested that Tanaka may resign following U.S. <u>President Ford's mid-November trip</u> to Japan. The <u>Financial Times</u> speculates that he will be replaced by the current Speaker of the lower house of the Japanese Diet, Shigesahuo Maeo, an associate of pro-Rockefeller leaders in Japan.

The Watergating of Tanaka, ostensibly over matters of personal corruption, has been orchestrated by the same forces which eliminate Nixon. The New York Times, CBS, and the Washington Post began shrill attacks on Tanaka two weeks ago. A week following their lead the Japanese press adopted the same tune, and then within a few days the politicians took up the line. Thus politics in Japan is being determined in New York, Washington, and Langley, Virginia.

If Maeo does succeed Tanaka in November, his government will not last. Instead, Rockefeller is introducing a period of programme chaos and confusion, taking away the paternal support of a stable government at a time when the Japanese working class already is terrified by bankruptcies and rising unemployment. Rockefeller expects that the fright caused by economic crises and a series of weak governments will lead the Japanese working class to accept whatever fas cist measures he proposes.

### Radiation Scare

In a related aspect of Rockefeller's programmed paranoia for Japan, the Hiroshima-scarred Japanese people have been frightened by reports that U.S. ships carried nuclear weapons while in Japanese ports. This is one of the issues on which Tanaka has been Matergated. Now, the government has announced that two nuclear reactors at electric plants have developed cracks in their water cooling systems Despite the fact that the radiation shield is still intact, preventing leakage, the press has created a new radiation scare.

### LA PRESSE PLAYS UP FOOD DESTRUCTION, COMING SHORTAGES

MONTREAL, Oct. 29 (IPS) -- One hundred livestock farmers took control of Louiseville, Quebec, Sunday, Oct. 27, stopping traffic into the town, spraying manure on the roads, and burning live veal calves and pigs. Losing between 20¢ and 45¢ per pound on every animal raised (depending on quality) and faced with a tight Rockefeller-manipulate

credit market, the growing desperation of these farmers erupted into anarchist outbursts patterned on the recent demonstrations of French German, and Belgian farmers.

Significantly, only <u>La Presse</u> covered the story making it front page news. Controlled by <u>Paul Desmarais</u>, a director of the Rockefeller company Brascan, <u>La Presse</u> is a steady mouthpiece for the cabal' propaganda. The publicity given to the farmer demonstrations in Morday's and Tuesday's papers was aimed at psychologically manipulating the Quebec population into a state of acute apprehension about the imminent food shortages, forcing them to blame the farmers for the situation.

Stressing that this demonstration is just the tip of the iceberg, La Presse related how thousands of veal calves already have been slaughtered throughout Quebec over the past days. Describing in detail the desperate financial situation of livestock raisers, La Presse indicated the need for price increases if farmers are to survive. Warning that livestock producers may kill not only veal calves, but cows and bulls as well, La Presse states: "What would be the proportions of a massacre by 35,000 milk producers, who also raise cattle, if they took the same decisions?" The message is clear: Either way--higher prices or no food--the Quebec working class will lose.

Several weeks ago over 1,000 Quebec cattle raisers met with Quebec agriculture minister Toupin to demand subsidies. Paul Couture, president of L'Union des Producteurs Agricoles, had sent demands to Premier Bourassa, calling for minimum price guarantees of 60¢ a pound and that agricultural producers get an income equivalent to industrialized workers. Toupin has said that this latter demand is "unrealistic" and La Presse leaked that Toupin will offer a meager 13¢ a pound subsidy tomorrow.

### KREISKY AND LEBER PLAN SECOND OCCUPATION OF EUROPE

WIESBADEN, BRD, Oct. 29 (IPS)--Chancellor of Austria Bruno Kreisky committed one of the worst diplomatic blunders since World War II when he spoke in Wiesbaden, West Germany Oct. 23, to an audience including West German Defense Minister Georg Leber. The speech followed a Kreisky-Leber tete-a-tete the night before in a Wiesbaden hotel restaurant.

Kreisky was in Wiesbaden, which has a NATO headquarters, ostensibly to commemorate the 50-year anniversary of the German insurance company of Hesse-Nassau. While admitting a long-standing relationship to the CIA-Council on Foreign Relations, Kreisky followed the Rockefeller's Trilateral Commission policy determined in Bellagio, Italy two weeks ago: "The relations of Western Europe and Central Europe (MittlEuropa) with the Middle East must acquire a different quality than those of the United States...although I do not presume

at this time to go into the role of the huge oil companies and their relations to the United States."

When questioned by European Labor Committee members in Wiesbade about his relation to the Trilateral Commission, Kreisky denied any connection, saying: "I only came to discuss security questions with Minister Leber." Georg Leber, West German Minister of Defense, was also present at the supposed anniversary speech.

That Kreisky would simultaneously mouth Trilateral Commission policy and deny any connection to the Commission was not surprising; but his use of the term "Central Europe" was. According to official West German government sources, "Central Europe" refers to countries which are now in the East bloc, in addition to Austria. Various Austrian government officials interviewed by IPS could not answer how their Chancellor would presume to determine East bloc policy toward the Middle East, but they volunteered that Kreisky's cover story for visiting Germany on the anniversary of an insurance company was nonsense.

Kreisky's meeting with Leber in Wiesbaden was in blatant violation of the conditions of the 1955 Treaty of Neutrality which established Austria as a neutral nation, free of occupation forces. The treaty forbids any military pacts between Austria and other nations and names the Soviet Union as a guarantor. In May of this year, Defense Minister Leber is known to have toured U.S. military installations at Secretary of Defense Schlesinger's invitation, accompanied only by one man—the Catholic Chaplain to the Austrian Army Franz Unger.

### Security Against Revolution

The key to Kreisky's visit lies in the "security questions" discussed with Defense Minister Leber. Since the military relationship between East and West depends totally on whether the Soviet Union cabe forced to accept the "conceptual breakthrough" of the tactical us of nuclear weapons, there is no question of either Austrian or West German security being a matter of defense against invasion. The onl security questions are those preparations for a working class revolutionary upsurge, precisely along the lines of Leber's reorganization of the German Army (Bundeswehr)—building professional killer-units with civil action capability.

The second occupation of Europe is planned to ensure internal security against the working class. On the economic front, an independent "democratically unified" Europe will determine austerity and this "unified Europe" will expand in definition to include the East bloc--the Red Hapsburger Kreisky's cherished "MittlEuropa."

IPS will interview diplomats from Hungary, Poland, the German Democratic Republic, and Czechoslovakia to advise them of the policies Chancellor Kreisky is propounding and to ask what their governments intend to do about this assault upon Austrian neutrality and their internal affairs.

### SALERA ON BALLOT IN PENNSYLVANIA; BARRETT OFFICE FREAKS OUT

PHILADELPHIA, Oct. 29 (IPS)--Pennsylvania Congressman William Barret from South Philadelphia's 1st Congressional District suffered a major defeat yesterday when the State Supreme Court ruled that his U.S. Labor Party opponent Bernard Salera will be on the ballot in November's election.

The State Supreme Court order read as follows: "The petition of William B. Sykes [a Barrett flunky] is hereby dismissed. The Commonwealth of Pennsylvania shall do everything in its power to see to it that Bernard Salera and the U.S. Labor Party retains its position on the ballot in Congressional District #1."

The Barrett machine, which has attempted to eliminate all electoral opposition by any fraudulent, underhanded means, freaked out in Washington, D.C. today when a member of the Labor Party stopped into Barrett's office to congratulate him on his defeat. A speechless Barrett aide extended his hands and sat dumbfounded, until ask what was wrong. He then began repeating: "Quiet, quiet, quiet.... Get out, get out," and called the police. Still shaking, he repeated over and over, "You can stay if you want, the police are coming, the police are coming." The Labor Party spokesman again asked what was the matter; was he upset by the U.S. Labor Party post er of Barrett? At that point a secretary came running out of a back room screaming "Filth, filth, filth..." The Labor Party representative left, while the two Barrett aides continued to scream hysterically.

### SPD ROUTED IN STATE ELECTIONS

Oct. 29 (SPD)--German workers suffered a major setback this week. Election returns from critical elections in the states of Hesse and Bavaria two days ago show that the working class based Social Democratic Party (SPD) was devastatingly routed. For the first time in the post-war period, the SPD lost its majority in its stronghold, Hesse. The reactionary Christian Democratic Union took the SPD's place as the state's largest party. The SPD lost every city in Hess and Bavaria except two, Kassel and Offenbach, which are thoroughly working class constituencies.

In Munich, the Social Democrat's Bavarian stronghold, the party was down 25 to 30 per cent from its 1970 vote, while the neo-fascist Christian Social Union gained a whopping 23 per cent.

Responsibility for the defeat lies squarely with the Rockefell agents in the SPD leadership, starting with Federal Chancellor Helmu Schmidt. Schmidt helped deliberately to sabotage his own party's Hesse election campaign with off-repeated "don't give a damn" state-

ments about it. In Bavaria, the SPD handed the election to the head of the Christian Social Union Franz-Josef Strauss by fielding a candidate, Hans-Jochen Vogel, who was almost indistinguishable from his fascist opponent.

### Dirty Work

Strauss is reaping the harvest of Schmidt's sabotage. He already has said publicly that "Schmidt is saving me a lot of dirty work." The election returns confirm that statement. Strauss increased his CSU majority in Bavaria from 55 per cent to 62 per cent, while the SPD percentage fell from 34 to 30 per cent. In addition, Strauss moved from his base in the Bavarian peasantry to score major sweeps in the traditionally SPD urban strongholds such as Munich. There, SPD candidate Vogel's de facto pro-CSU stance, his purge of party leftists, and high industrial employment threw the victory to the CSU.

Nothing better illustrates the success of Schmidt's electoral sabotage than the "historic first" of the Hesse Christian Democratic Union (CDU), led by Strauss' ally, Alfonse Dregger, beating the SPD in Frankfurt. In this SPD bastion, the CDU garnaged 45 per cent of the vote compared to the SPD's 42 per cent. The electoral trend highlighted by Frankfurt demonstrates that the SPD refusal both to expose Schmidt's treason and to ally with the European Labor Committee's united front campaign rapidly is bolstering fascist Strauss' national stature. To the extent that the SPD continues to capitulate to Rockefeller, Strauss will continue to expand outside of his Bavarian bailiwick, picking up masses of radicalized non-working class layers.

### SPD Left Purge

With the elections barely over, the party traitors grouped around Schmidt are moving to cover up their criminal tracks with a smear campaign that "radicals and leftists" in the SPD are responsible for the Schmidt-caused defeat. This was coupled with explicit threats of a coming party mass purge by SPD Deputy National Party Chairman Heinz Kuehn, a Schmidt ally. Kuehn warned: "There could come a day when the party will have to separate itself from certain people. The letting go of about 100 extremists must then be risked, to prevent 100,000 from leaving us." Kuehn followed this up by stating that getting rid of the left was the precondition for future electoral successes. This is an outright lie, of which Kuehn is well aware, for such a move would cause a mass exodus of workers from the party.

# FAO TO PUSH FASCIST MASTER PLAN AT WORLD FOOD CONFERENCE

UNITED NATIONS, N.Y., Oct. 28 (IPS)--IPS has examined the major documents to be presented to the upcoming World Food Conference in Rome by the UN's Food and Agriculture Organization (FAO). Written in their entirety by the Rockefeller Foundation, the FAO documents contain a master-plan for fascist world food control and labor-intensivagriculture.

The FAO will propose the establishment of a supranational World Food Authority whose responsibilities are two-fold: To establish a "world food reserve" grain rationing system and to establish an Agricultural Development Fund with a \$5 billion per year capital budget.

The "world food reserve," already exposed in detail by IPS, will allow food distribution only to countries specially selected for slave labor "development." Existing "food for work" programs, currently sponsored by FAO and the World Bank, will be greatly expanded Under these programs, workers are paid "in kind" rather than cash, with food allotments so meager that their families inevitably must starve.

The Agricultural Development Fund will coordinate the financing of labor-intensive agricultue in Third World countries to maintain the minimal food production necessary for slave labor. As Rockefeller's credit squeeze wipes out mechanized farming in the advanced sector, even North American and Western European workers will become totally dependent on Third World food imports.

Under the guise of eliminating Third World famines, the FAO's Agricultural Development Fund will siphon \$5 billion a year into expanding production in the Southern Hemisphere. An additional \$5 billion will be raised through the World Bank and "recycled Arab petrodollars" skimmed off workers' and farmers' incomes via the Oil Hoax.

### Labor-Intensive Agriculture Only

The FAO documents make it crystal clear that only labor-intensive agriculture is under consideration. Nowhere in the hundreds of pages on "proposals for action" is investment in labor-saving agricultural machinery even mentioned, except to say that it is undesirable because it "causes unemployment." The only increased inputs will be in irrigation, fertilizers, pesticides, and seeds--and even then only in selected areas. The FAO's Rome office already has organized an international Fertilizer Pool to raise funds for fertilizer imports and the building of fertilizer production plants in the Third World.

Similar stocks will be set up for pesticides and seeds. As for irrigation, this largely will involve renovation of existing facilities. The FAO prescribes "labor-intensive construction methods" for all new irrigation, two-thirds of which will be built in the Far Eastern sector with secondary emphasis on the Middle East.

Even labor-intensive agriculture will not be expanded to the entire Third World. According to the cabal's plan, certain zones have been selected as more profitable than others for capitalist looting purposes. The Sahel region of Africa, most of India, and Bangladesh are already written off by the World Bank as "non-credit-worthy," as induced famines are allowed to wipe out millions of the "useless eaters."

### Development Regions

The FAO has specified four major regions where "large-scale lar development" will take place: the Amazon basin, Mekong basin, South ern Sudan, and Middle Africa. The first three areas will require "major infrastructure building, massive investments and wholesale resettlement of population." The opening up of the fourth area in middle Africa will involve the elimination of the tsetse fly to allow livestock production, as partial replacement for the wiped-out livestock industry in the advanced sector.

The oil company-run Middle East is also under special consideration by the Rand Corporation and the Rockefeller and Ford Foundation as a site for agricultural expansion. In an Oct. 23 New York Times article, "Oil Money May Make the Mideast's Deserts Bloom," the Sudar and Syria are cited as investment priorities. With some investment in its transportation system, the Sudan will become the major source of fodder crops for sheep-raising in Saudi Arabia, Jordan, and Syria while Syria will expand its wheat production through increased irrigation. World fertilizer production also will be shifted to the Middle East to take advantage of natural gas supplies and cheap labor.

#### The Maoist Way

One of the FAO's chief concerns is so-called rural development and the organizing of small farmer "participation" by agricultural extension agents. The Maoist "communal" form of peasant organizatic is advanced by FAO as the best way to insure that peasants increase their output and pay off their debts. "There really is no effective way to solve the problem of the small farmer until he ceases to be a small farmer by joining a bigger and more viable unit, not as a hire worker but as an active member with a strong stake in its success." Suggested models include the Mexican Ejidos, Israeli Kibbutz, Tanzanian Ujaamas, and Egyptian Agrarian Reform Institutions. Under the Tanzanian system, established with the help of Chinese advisors, farmers must speed themselves up and perform free labor "for the goo of the community" to avoid losing their plot and being abandoned to starve.

The FAO reserves its most enthusiastic blandishments for Maoist China itself: "There is, however, one outstanding exception, namely China, where a rather special approach has been adopted, where technology has been adapted to the people instead of trying to adapt the people to the technology. The Chinese have expected the rural communities to help themselves in modernizing agriculture, to create additional local employment outside farming and to build up the social services...What is required [in other countries] is that these objectives be pursued with much more political zeal and seriousness so that poorer sections of the people can organize themselves for bring about a betterment of their life and living."

### Red Cover for Fascism

What the FAO report omits is that the fragmented, communal form of production and lack of technology is actually the greatest weakness of the Chinese. Without a massive expansion of agricultural machinery production, Chinese food output necessarily must continue to stagnate. As at the UN World Population Conference in Bucharest earlier this year, praise for Maoist methods serves merely to lure the Chinese into providing a left cover for fascist policies—as the Chinese economy is opened up for capitalist penetration and takeover

FAO credit policies reveal the actual purpose of pushing Maoist "local control" institutions. Of the \$1.2 billion allocated by FAO for farm credit each year, at least half is slated for small farmers. The catch is that FAO-recommended "realistic" interest rates range a high as 10 to 12 per cent for short-term farmer purchases, such as fertilizer. The FAO identifies two stages in credit policy: (1) the stimulation of a changeover to "more modern and profitable types of farming" and (2) the mobilization of "agricultural savings for recycling, i.e., relending." In plain language, farmers will work themselves to death to pay back usurious debts, with the cooperative ensuring that everyone does his share. As one peasant population looted dry, their "savings" will be recycled and relended to a new victim population.

Slave labor, starvation, and depopulation—such is the fascist "new international order" envisioned by David Rockefeller's Trilater al Commission, the World Bank, and FAO. The FAO conference is entirely Rockefeller Foundation—staged, a pretense at democratic discussion among governments with Rockefeller controlling all the "options." As shown by current U.S. State Department moves to organize a world food reserve, Rockefeller forces will implement their food policies through other channels—even if the World Food Conference should prove a flop.

### The Solution: Expand Production

At this point, only the organizing of the International Caucus of Labor Committees for a workers' united front, including the major European Communist and socialist parties, can possibly stem Rockefeler's advance and ensure the survival of humanity. Representatives of the ICLC and united front representatives will be at the Rome

conference, briefing delegates who might otherwise be duped into endorsing the Rockefeller master plan. As at the World Population Conference, the ICLC is presenting its own counterproposal for massive increases of industrial and agricultural production through an expansion of East-West trade. Under the Labor Committee program, Western Europe will supply the Soviet Union with capital goods necessary to increase its food production and upgrade the consumption of workers world-wide. A crash program to develop thermonuclear fusion power will provide the cheap energy source necessary to sustain this exponentially-expanding production.

# FARM ORGANIZATIONS IMPLICATED IN DRIVE TO REDUCE MEAT CONSUMPTION

Oct. 28 (IPS)--Timed with the release of Rockefeller agent Lester Brown's new book By Bread Alone, the U.S. press has produced a spate of articles calling for "meatless days" as the solution to world foo shortages. A front-page Oct. 25 New York Times article mouthed Brown's line that "overfed" Americans must reduce their meat consumption by at least 10 per cent so that grain normally "wasted" in live stock-feeding can be used to feed the starving in "developing" countries.

The <u>Times</u> has employed fraudulent nutrition methodology in pushing the anti-meat line. Grains not only lack sufficient amino acids necessary for protein usage, but also fail to supply human vitamin and unsaturated fat requirements provided by meat.

### NFO: Anti-Meat

In an IPS interview, a National Farmers' Organization (NFO) spokesman at their national office repeated the anti-meat line and advocated a world food reserve--the Rockefeller-backed grain rationing system. Further IPS probing has revealed that both NFO presiden Oren Lee Staley and National Farmers' Union (NFU) head Tony Dechant sit on the board of the Freedom from Hunger Foundation.

Since its formation in 1963, the Foundation has worked in tander with the United Nations' food control agency, the Food and Agriculture Organization (FAO). The Foundation's first president was forme NFU head and FAO advisor James G. Patton. The Foundation is the chief funding conduit for the World Hunger Action Coalition, which i sponsoring "hunger banquets" and pro-starvation conferences around the country in preparation for the World Food Conference. Collaborating closely with Lester Brown's Overseas Development Council, a Rockefeller Foundation-funded outfit, the Coalition is pushing heavily for reduced meat consumption by exploiting peoples' guilt feeling concerning famine in other countries.

Tony Dechart, in particular, is no mere innocent dupe for Rocke-feller; he sits on an advisory committee to the Overseas Development Council think-tank. The irony is that farmers should fall for so-called leaders who advocate a program which can lead only to mass bankrupting of American meat and grain farmers and further genocidal cutbacks in world food output.

A series of aggressive U.S. Labor Party interventions into the World Hunger Action Coalition starvation conferences has destroyed their effectiveness in perpetuating the food hoax. In Philadelphia Oct. 25, Rockefeller man Lester Brown was reduced to a catatonic state when a Labor Party spokesman informed him he was indictable under the Nuremburg code for crimes against humanity. Unable to finish his scheduled talk, Brown stood speechless as the Labor Party briefed the audience on Rockefeller's food policies.

Three newspaper and magazine reporters at the conference demanded interviews with Labor Party Congressional candidate in Pennsylvania's First District, Bernie Salera.

#### LET THEM EAT WOOD CHIPS

Oct. 28 (IPS)--Still another anti-meat hoax to be perpetrated on farmers and consumers is a series of proposals to feed cattle on wood chips and paper mill wastes. U.S. Department of Agriculture animal nutritionist Dr. David A. Dinius has produced a report providing the "scientific" justification for this insane practice.

Also, a representative of the Nazi Kruppwerke advocated the use of brewery wastes for animal feed at a recent Denver environmental conference. To top off the quackery, researchers at Washington State University reportedly are looking for a "high-protein potato" as another meat substitute.

### JAPANESE FARMERS SLATED FOR EXTINCTION

Oct. 28 (IPS)--Japanese farmers, 85 per cent of whom depend on seasonal industrial labor to stay alive during the winter, have been slated for extinction. The tight credit policies of the Rockefeller-controlled Bank of Japan have allowed the collapse of the entire Japanese textile industry and most of the electrical and appliance sector. As a result, about 400,000 seasonal workers, mainly farmers, were not rehired this year.

Recently, the consumer price of rice in Japan was raised 34 per cent as a concession to farmers, who are the main constituency base of Tanaka's ruling party. The chief effect will be to pit workers' rage against the farmers. Farmers still will be bankrupted because

of soaring diesel fuel and fertilizer costs, as well as the cutbacks in seasonal hiring.

Rockefeller mouthpiece Nakasone, head of the Ministry of International Trade and Industry, has just released an 84-page "Direction for Japan's Industrial Structure," which lays out the ultimate fate of Japanese farmers. One-half of the industry of the main Tokyo-Osaka industrial belt is to be shut down and large parts relocated the present predominantly agricultural districts. Furthermore, agricultural import liberalization will be stepped up as part of an envisioned "new international division of labor." The once-heavily protected Japanese farming will now be wiped out, as resettled Japanese slave laborers instead are fed on cheap food imports from China and South Asia.

# COTTON AND WOOL FARMERS BANKRUPTED IN WORLD TEXTILE COLLAPSE

Oct. 28 (IPS)--Cotton and sheep farmers world-wide are being washed under as the textile industry collapse drives their prices down 50 per cent from last winter's high. Cash-strapped fiber, yarn, and fabric producers have been forced to dump their inventoreis, thus furthering the collapse of prices offered farmers on the commodity markets.

The textile-apparel industry has been hit by Rockefeller's credit squeeze and plummeting consumer demand, as declining real wages force workers to cut back on new clothing purchases. Textile plant closings and layoffs are now spreading throughout the U.S., Japan, and Western Europe. Although local natural gas and coal "emergencies" often are used as an excuse for the closings, the world-wide character of the depression belies this cover story.

U.S. farmers have attempted to protect themselves by holding much of the large cotton crop off the market, taking out loans from the government Commodities Credit Corporation at the usurious rate of 10 per cent. In Mexico, where the incomes of five million people depend on cotton production, producers have called for the formation of an OPEC-style international organization of cotton-producing countries—an absurdity destined only to isolate farmers.

### ARAFAT JOINS PRESS BUILD-UP FOR MIDEAST NUCLEAR WAR

Oct. 27 (IPS)--In an interview with the Egyptian weekly Rose al-You-sef, Yasser Arafat, head of the Palestine Liberation Organization (PLO), stated that a new Arab-Israeli war might involve "the nuclear factor." Terming such a war "more probable than a settlement," Arafat said that time is on Israel's side.

Arafat, the leading "radical" mouthpiece for Rockefeller's Mideast war strategy, also linked Jordan to Israel as part of a conspiracy that involved the U.S. "How can we speak about a settlement while Israel is actively preparing for a war aided by North America and Jordan, who want to preserve Hashemite domination over the Pales tinian people," Arafat said.

### BRITAIN ADOPTS "ACCEPTABLE FACE OF FASCISM"

Oct. 29 (IPS)--Despite the "red menace" stories in the leading bourgeois press, the Oct. 10 General Election in Britain was not a mandate for the "socialist" policies of the majority Labour Party, but the final step toward openly fascist rule in Britain.

Since 1945 when what remained of British capitalism was mort-gaged to the U.S. via the Lend Lease Program, successive British governments have been forced to prolong its life. They did this, in the words of former Prime Minister Edward Heath, by making acceptable the "unacceptable face of capitalism."

Now, as Rockefeller has consolidated his grip on the international financial community, even this shred of pretense is no longer necessary. Observers of the British scene now readily note that the country has moved into a new phase in which the political parties, increasily indistinguishable from each other, are putting forth nothing less than the "acceptable face of fascism."

### Accepting the Unacceptable

These were the exact words of two Eritish professors, who, writing recently in the periodical New Society, were forced to admit what has been blatantly obvious to readers of New Solidarity and IPS since early this year.

Mincing no words, they wrote:

"What all the major parties have done is take over the core elements of the economic strategy which the Italian fascists, Salazar in Portugal, the Falange in Spain and the Nazis adopted to deal with the inter-war crisis. What the parties are putting forward now is an acceptable face of fascism; indeed a masked version of it, repugnant political and social aspects of the German and Italian regimes are absent or are only present in selected form."

It is only on their last point that the professors were wrong: The truth of their pronouncement is borne out not only by the overt swing toward fascist economic policies masquerading as "capitalism," but by the intersection of these corporativist designs with openly fascist social policies.

In terms of the ruling Labour Party's current economic policies the professors did hit the nail squarely on the head. Specifically, the present government, with the approval of the Opposition Conservative Party, is planning to "restructure" the economy along outright fascist lines, getting the working class to agree to self-imposed austerity enforced by their own "social contract."

Long hounded by Britain's leading capitalists who rightly agree that the floor was rapidly sinking beneath them, the Chancellor of the Exchequer Denis Healy has announced that Nov. 12 he will reflate (pump money into) the economy in order to save large sections of British industry from imminent bankruptcy. It is through such "selective" boosts to the industrial sector via Healey's budget and Labour Party financial wigard Harold Lever's proposed National Investment Bank that the British economy will be restructured in a fascist mold.

### The "National Interest"

The cornerstone of such a plan was crystal clear to Employment Minister Michael Foot. He noted that the designs implicit in Healey budget would go "up the spout" if the trade unions did not adhere to the social contract, the British workers' promise to the government to voluntarily slash their standard of living by sacrificing wage in terests in the "national interest."

To facilitate the implementation of "the acceptable face of fascism," the tight-fisted credit policies of the Rockefeller-affiliate banks in London had manipulated a dangerous liquidity crisis in the industrial sector. They forced British capitalists to their knees, begging for an injection of funds, even with "strings" attached. Faced with increasing material and wage costs, but unable to raise money through traditional channels, British industry has been cutting production, laying off staff, and cancelling current investment plan on a massive scale. "Nobody should be under the impression that we are crying wolf," said the head of Britain's employers' union, the Confederation of British Industry. "The wolf is already nibbling at Red Riding Hood's coat."

Who the hungry wolf is should not be too difficult to figure ou Gordon Richardson, head of the Bank of England and direct representative of the Rockefeller interests, warned recently that even Chancel

lor Healey's promise of a reflationary budget with relaxed credit controls would not be enough to save industry, since companies were not even creditworthy enough (for Rockefeller) to qualify for loans. However, if they could increase profitability, without increasing wages, well then, maybe.

Picking up the scent, Healey was quick to promise that his budget plans did not signal a step away from the austerity policy the government has been implementing since March. He urged: "We must follow any increase in our living standards as a nation until the fundamental re-adjustment has been carried through."

### "Fundamental Re-adjustment"

This "fundamental re-adjustment" toward overt slave labor policies is implicit in Lever's National Investment Bank proposal which would involve turning on the tap for "deserving" industries, with no strings attached, just "prods." The proposed NIB, as it already is being called, would sidestep the collapsing secondary banking sector and funnel funds directly from private banks and financial institutions. However, it will not even begin to bail out credit-hungry small and medium-sized domestic industry. It is not meant to. Its stated purpose, along with Anthony Wedgewood Benn's National Enterprise Board, is to "re-structure" British industry by investing only in selective projects. This money will go for the slave labor projects in North Sea Oil and related industries while the skilled work force for these projects is freed through increasing numbers of bank ruptcies in "non-essential consumer industries."

The much-lauded social contract is the perfect complement in this scheme. True to his role, Jack Jones, leader of Britain's largest union, the powerful Transport Workers Union, has chimed in with a winning prescription for the problem of how to maintain corporate liquidity when the country is bankrupt. In Scotland, where eight major strikes, involving a total of more than 22,500 transport, sanitation, and auto workers threaten to paralyze key cities, Jones told a working class audience: "A wonderful wage agreement is of no valuif the firm with which we have negotiated does not employ people any more."

With his "wonderful," but valueless pay packet, Jones has spellout the clear choice for the working class: If you don't want to wind up on the unemployment lines, forget wage increases, concentrate on productivity, and be grateful for any wages you are lucky enough to get. Or else, face a rightwing backlash, probably through the barrel of a gun.

As if to accentuate the latter "alternative," already in the Northwest of England contiguous to the strike area, 600 soldiers of the Territorial Army Volunteer Force (the British National Guard) have just completed one of the stiffest tests of their "capacity for rapid mobilization." And one Conservative MP has warned in reference to the Scottish strikes: "If it proves there is not any practical value to it [the social contract] we have got to get down very smartly to the Government taking action to maintain essential services."

#### Nazi Social Policies

No sooner had the fascist economic wheels begun to spin when the complementary Nazi-like social policies began to emerge at an alarming rate. Shadow Home Secretary Keith Joseph, a pet protege of fascist Enoch Powell, exploited the current leadership vacuum of the Conservative Party (which polled its lowest share of the vote in recent years) with an outright Mazi prescription for the nation's ills

In the primarily working class area and nationalist stronghold of Birmingham, Joseph readied the country for Powell's return by delivering an impassioned plea to halt the moral decline of the nation His speech rivalled his mentor's anti-immigration speeches of the 1960s in their racist content. Advocating birth control for the deprived class to avert the dilution of the "pure British stock," Sir Keith, who is Jewish, sounded more than vaguely reminiscent of the Master Race theories of Nazi butcher Adolph Hitler as he warned: "The balance of our population, our human stock is being threatened. a higher and rising proportion of children are being born to mothers least fit to bring children into the world and bring them up...to mothers who were unmarried, deserted, divorced...some of low intelligence, most of low educational achievement."

#### Red Baiting

Sir Keith rounded out his attack on the moral degeneracy of the nation with some well-placed red-baiting, blaming "left-wing gangs" whose "well-orchestrated sneers...have weakened the national will to transmit to future generations those values, standards, and aspirations which have made England famous the world over."

Even though Enoch Powell, the most readily available fascist demagogue in Britain, returned to Parliament this election on a cres of nationalism and parochialism, his credibility with the traditiona Conservative Party is badly shaken due to his traitorous advise to vote "Labour" in the last two General Elections. But Sir Keith, from his "safe" vantage point within the party which Powell helped to destroy, has been skillfully paving the way for Powell's return, espousing first his "monetarist" economic views and now his racist social policies.

Powell already has predicted in the Op Ed pages of the prestigious London Times that "the double general election of February-October 1974 marked the close of the 30 year post-war phase of British politics. The nature of the new phase is only shadowly defined. When the politicians of the center who merely "muddle through"--like Heath and Wilson--are no longer adequate to be fascist policemen, Powell will be only too ready to accept the call.


### "The Enemy Within"

In case the election results had not entirely destroyed the final remnants of faith in bourgeois democracy and its institutions, leading counterinsurgent Brian Crozier (who instigated the "reds

under the beds" scare during last winter's miners' strike) came out with a new book outlining the military arm of these fascist economic and social policies. From his post as director of the Institute for the Study of Conflict, a CIA think-tank, Crozier defines once again the threat more subtle than Russian tanks--internal subversion. He recommends creation of a "No Party" military state and a super CIA called the Department of Unconventional Warfare to deal with malcontents. Former British Intelligence officer Lord Alun Chalfont has found Crozier's analysis, if not his conclusions, useful to augment his own pet theory: That defense cuts are too risky, not so much because of a threat to NATO, but because of the enemy within.

These sentiments, coupled with the open perpetration of fascist economic policies, coincide, not accidentally, with the advent of Rockefeller's second Oil Hoax. As the British worker is being primed for an Oil Hoax rerun, he has all but obliterated from his mind the psychological degradation he suffered last winter during the hoked-up miners' strike. Yet it was Rockefeller's manipulation of the coal supply compounded by last year's Oil Hoax which has paved the way for the British workers' acceptance today of the "acceptable face of fascism."

### "HEADS THEY WIN...TAILS WE LOSE"

(IPS) — For seven pence an hour additional "condition money," paid for working in hazardous depths requiring four days decompression, British workers desperately gamble their lives away in deep sea oil drilling projects in the North Sea. Already, the turnover rate at some sites is 140 per cent. During the next ten years, 400,000 men are to be cycled through a half-dozen sites nationalized by the British government.

The Permanent Under-Secretary to the Department of

Energy, Dr. Gavin Strang, has pledged to relocate thousands more to maintain Rockefeller's financial backing:

"North Sea oil presents British industry with a new and important market right on its doorstep. We have the chance to develop a major new industry to meet the needs of the offshore operator not only in the North Sea but in other waters throughout the world."
