MAYOR DALEY, DEM MACHINE LAUNCH POLICE STATE IN CHICAGO

CHICAGO, FEB. 17 (IPS) -- FEDERAL POLICE AGENCIES, WITH THE CONSENT OF CHICAGO'S MAYOR DALEY AND THE BLACK DEMOCRATIC MACHINE, HAVE OPENED UP A NIGHT AND FOG GESTAPO TERROR OPERATION IN THE CHICAGO AREA. ON SUNDAY, EIGHT BLACK LABOR PARTY SUPPORTERS WERE ILLEGALLY DETAINED, INTERROGATED AND THREATENED SHOULD THEY PUBLICALLY REVEAL THE TERROR OPERATION. HOURS EARLIER, ANOTHER BLACK LABOR PARTY SUPPORTER'S BROTHER-IN-LAW HAD BEEN "SHAKEN DOWN" BY A PURPORTED CHICAGO POLICE OFFICER FOR 10 DOLLARS. ALL OF THE LP SUPPORTERS HAD BEEN ON THEIR WAY TO A LABOR PARTY RALLY. THESE "NACHT UND NEBEL" GESTAPO TACTICS WERE AUGMENTED WITH DIRECT STRONG-ARMING OF CHICAGO POLITICIANS TO NOT WORK WITH THE LABOR PARTY, STRONG-ARMING THAT CAME THROUGH THE BLACK DEMOCRATIC MACHINE "FROM THE TOP."

WITHIN 48 HOURS OF THESE POLICE STATE ACTIONS, LABOR PARTY MEMBER PAULETTE ROBINSON WAS ILLEGALLY STOPPED BY NEW YORK POLICE AND DRUGGED INTO UNCONSCIOUSNESS. MS. ROBINSON IS NOW IN "GOOD" CONDITION AND HAS TODAY SUBMITTED A TAPED DEPOSITION REGARDING HER ORDEAL.

THE CHICAGO EVENTS BARE CLOSE COOPERATION BETWEEN THE FBI-LEAA GESTAPO APPARATUS AND THE DALEY MACHINE. ON THAT SUNDAY, THE 15TH, THE BROTHER-IN-LAW OF LABOR PARTY SUPPORTER MRS. BROWN WAS STOPPED WITHOUT REASON BY A CHICAGO "POLICE OFFICER" ON THE SOUTH SIDE. THE "OFFICER" DEMANDED 10 DOLLARS FOR "DINNER." THE CHICAGO POLICE SQUAD CAR LICENSE NUMBER USED IN THIS OPERATION WAS REPORTED TO THE LABOR PARTY HEADQUARTERS WHO IN TURN IMMEDIATELY CONTACTED THE CHICAGO PD WATCH COMMANDER. THE WATCH COMMANDER DENIED THE EXISTENCE OF SUCH A CHICAGO PD LICENSE PLATE NUMBER. THE USE OF SUCH A CAR AND DRIVER COULD ONLY BE A CAPABILITY OF THE LEAA OR THE FBI WITH THE COMPLICITY OF THE CHICAGO POLICE.

THREE HOURS LATER, EIGHT LP SUPPORTERS IN TWO CARS WERE SIMILARLY STOPPED BY POLICE. THE EIGHT, ALL MEMBERS OF A BLOC CLUB FROM THE SAME SOUTH SIDE NEIGHBORHOOD, WERE DETAINED WITHOUT CHARGES FOR ELEVEN HOURS UNTIL 3:00 A.M. DURING THE COURSE OF THEIR DETENTION, THE EIGHT WERE DRIVEN APPROXIMATELY 12 MILES BETWEEN DIVERSE POLICE PRECINCTS, INCLUDING THE CHICAGO PD HEADQUARTERS IN DOWNTOWN CHICAGO, INTERROGATED AND THREATENED WITH 25 DOLLAR FINES EACH IF THEY DID NOT SWEAR TO "KEEP QUIET" ABOUT THE ILLEGAL DETAINMENT.

COMBINED WITH THESE POLICE TERROR OPERATIONS, INFORMED SOURCES WITHIN THE DEMOCRATIC INFRASTRUCTURE OF NEARBY HEAVILY LP PENETRATED DISTRICTS REPORT THAT BLACK ALDERMAN, JAMES TAYLOR, HAS BEEN DIRECTLY CONTACTING OTHER POLITICIANS AND BLACK FIGURES IN THOSE COMMUNITIES TO TELL

THEM NOT TO WORK WITH THE LP. ACCORDING TO THIS SOURCE, ORDERS TO THIS EFFECT ARE ALSO COMING DIRECTLY "FROM THE TOP."

A CHICAGO SPOKESMAN FOR THE USLP STATED, "DESPITE DENIALS FROM MAYOR DALEY'S AIDE, KEN SAIN, THAT THE MAYOR WAS DE FACTO WORKING IN COLLUSION WITH THE JUSTICE DEPARTMENT AND THE FBI TO TERRORIZE LP SUPPORTERS AND BRING ON POLICE STATE CONTROL OVER THE AREA'S WORKING POPULATION, UNLESS MAYOR DALEY COMES FORWARD WITH AN IMMEDIATE INVESTIGATION INTO THOSE AGENCIES AND DEMOCRATIC MACHINE FIGURES RESPONSIBLE, HE WILL BE HELD DIRECTLY ACCOUNTABLE BY WORKERS WHO KEEP HIM IN HIS POSITION AS MAYOR. THE LABOR PARTY HAS ALREADY INITIATED AN INVESTIGATION AND PLANS TO RELEASE THE FINDINGS ON AN ONGOING BASIS. THE FIRST SUCH PUBLIC REPORT WILL OCCUR ON WEDNESDAY MORNING AT 11:00 A.M. AT A U.S. LABOR PARTY PRESS CONFERENCE IN FRONT OF CHICAGO POLICE DEPARTMENT HEADQUARTERS AT 11TH AND STATE ST."
